If you or someone you know or love is a victim/ survivor of domestic violence or sexual assault, help is available.

- Individual Advocacy If you need someone to confide in, we are available to listen. We can offer you a safe, confidential, and non-judgmental space to talk on or off campus.
- Title IX Advocacy We can inform you of, and support you during, the Title IX process. We can go with you to the hearings and assist you by educating and supporting you throughout the entire process.
- Hospital Advocacy An advocate can go with you to the hospital after a physical or sexual assault. We can answer any questions you may have about the process and what will happen next.
- Legal Advocacy If you choose to report your assault to law enforcement, we are here to support you and help you through the reporting and court process.
- **Safety Planning** Your safety is our top priority. We can help you develop an individualized plan to stay safe on or off campus.
- Emergency Shelter If you are in need of a safe place to stay due to domestic violence or sexual assault, we can help. Our shelter is available 24/7.
- Campus Support Group This peer support group meets on campus and provides survivors of sexual violence a safe, supportive, and non-judgmental space to heal. Call 419.289.8085 for more information or to attend.

## What is Title IX?

Title IX is a portion of a federal law that prohibits discrimination on the basis of sex, including sexual misconduct, on university campuses. Title IX requires the University to investigate complaints of sexual misconduct when requested by the complainant or when multiple reported violations are received implicating the same violator(s). Non-confidential resources are required to inform the University's Title IX Coordinator when made aware of sexual misconduct.

Sexual Misconduct is a broad term that encompasses a range of inappropriate behaviors. It can occur between strangers, acquaintances, people who know each other well, and current or former partners. It includes gender based harassment, indecent exposure, intimate partner violence, sexual violence, sexual harassment, and stalking.

## Submitting a Report
